The Arizona Roofing Industry Foundation (ARIF) is a nonprofit organization made up of Arizona Roofing Contractors Association (ARCA) members with a primary mission to provide academic scholarships for continuing education opportunities to employees of the roofing industry.



NRCA HAS BEEN conducting personal breathing zone sampling on roofing job sites where silica may be present to assess worker exposures to respirable crystalline silica (RCS). This effort is intended to establish roofing industry objective data that contractors can rely on, particularly when performing tasks not listed in Table 1 of OSHA's regulation. Industry objective data can relieve contractors from the expense of conducting their own sampling if the tasks being undertaken are similar to those found in the objective data. In the majority of sampling conducted on asphalt shingle, polymer-modified bitumen and built-up roof tear-offs and installations, exposures not only were below the permissible exposure limit (PEL) but also below the action level and in many instances below the limit of detection. Levels of total respirable dust also were well below the OSHA PEL.

In addition, sampling was performed on tasks such as drilling into concrete or masonry for fastener attachment, cutting and fastening gypsum roof boards, and installation and removal of roof gravel or ballast—all with equally positive results.

Arizona has not yet adopted the standard. ARCA will keep you apprised when implemented and our Safety Committee will send out step by step directions to achieve compliance. 🏠

Home of Hope Receives New Roof



CASA GRANDE — Since a storm flooded their facility two years ago, staff and residents at the Home of Hope in Casa Grande have dreaded the approach of a rainstorm.

“One room has been out of use since the storm, and when it rains the chapel leaks periodically,” said the Rev. Teresa Logue, who runs the residential drug- and alcohol-recovery facility.

But this week, with the donation of a new roof from the National Women in Roofing Arizona and members of the Arizona Roofing Contractors Association, Logue said the facility no longer fears the rain.

“I’m so grateful,” she said. “I can’t wait to open up that room again so we can help more women and children.”

The members of the National Women in Roofing Arizona Chapter support philanthropy and giving back, said Jennifer George, communication specialist for the Arizona Roofing Contractors Association.

In 2017, NWiRAZ President Valorie Miller of JBS Roofing learned that Home of Hope needed a new roof. Employees of JBS Roofing visited the facility and assessed the roof. A NWiRAZ committee voted to take on the project with members of the committee volunteering their time and materials for the new roof.

Home of Hope’s roof was severely damaged in a 2016 storm that caused

about \$10,000 in interior damage.

“The storm flooded our front office, destroying our fire-alarm system. It had to be completely rebuilt,” Logue said. “Our chapel was flooded. We had to replace drywall in one of the student rooms.”

Home of Hope is a Christian-based residential drug-treatment center for women 18 and older. Located on North Casa Grande Avenue, it’s one of the few shelters where recovering women may reside with their children while they receive treatment.

But the storm and flooding forced the organization to close one of the student rooms.

“That room has been out of use since the storm,” Logue said. “We kept thinking we could use the student room and then it would rain and destroy all the repaired ceiling drywall.”

After the volunteer roofers inspected the facility and its roof, Logue learned the roof would need to be replaced.

“The roofers explained that the wood was rotted and no matter how much tar we put on it, it would eventually leak,” Logue said.

With the roof now repaired, the drywall in the student room will soon be replaced and then it will be available for women and children.


Home of Hope is a division of Teen Challenge of Arizona. It provides an

atmosphere of healing and the tools and education necessary to help women overcome their addictions, restore appropriate family relationships, obtain and retain employment, and become productive members of the community.

The program has an 86 percent success rate and has helped more than 700 women overcome addiction over the years. It’s also reunited 126 women with their children.

Several companies contributed to the new roof, including APOC, Elite Roofing Supply, FT Synthetics, JBS Roofing Co., Lyons Roofing, Malarkey Roofing Products, Polyglass Roofing & Waterproofing Systems, Sierra Waste Systems, Tecta America Arizona and Tropical Roofing Products.

National Women in Roofing Arizona is a volunteer-based organization that supports and advances the careers of women roofing professionals. It provides networking, mentoring, education and recruitment opportunities for the young professionals at the start of their careers up to the seasoned manager in the executive suite.

The Arizona chapter is a board-approved committee with the Arizona Roofing Contractors Association comprised of more than 40 members, including women and men who support the inclusion of women in the roofing industry. 

LEGISLATIVE UPDATE

STATE OF ARIZONA

Summer study sessions began August 1st on several issues important to the roofing cadre in AZ:

- **Proportional Liability Reform**—ARCA and our trade coalition partners are meeting with Senator Fann to work on the committees scope of work, focus and plan of action. The desired end result is to have language already codified for government work apply to private commercial / residential contracts where any contractor can only be accountable for damages they actually caused.
- **Transaction Privilege Tax**—Study on non-compliance being conducted by independent economist going on simultaneously with discussions on how to fine tune language so that it is easily understood without ambiguity regarding work considered Prime contracting versus MRR.

FEDERAL

The Trade War Escalates

The Trump administration announced plans to impose new tariffs on an additional \$200 billion worth of imported products from China in retaliation for tariffs the Chinese government imposed on the U.S. July 6, which was a response to an opening round of additional U.S. tariffs on \$34 billion of imported Chinese goods. The new tariffs would not take effect until September at the earliest and could be averted if the U.S. and China reach some type of accommodation regarding bilateral trade before then. The Trump administration also is considering levying new tariffs on imported automobiles and auto parts from other countries, including Japan, South Korea and the European Union. As these tariff developments are playing out, the Senate last week voted 88-11 in favor of a non-binding resolution to require the president to get congressional approval before using national security as a basis for imposing tariffs. The non-binding nature of the action indicates lawmakers don't have the votes to pass anything to force the president to change course regarding trade policy. If the administration can secure trade policy concessions from our trading partners, this could avert the need to impose the new tariffs and possibly rescind existing tariffs.

The Department of Labor Issued its Final Rule on Association Health Plans (AHPs)

In accord with President Trump's Executive Order in October 2017, the Department of Labor issued a final rule designed to make it easier to form AHPs as a way of lowering health care costs. Before the final rule, small businesses were required to demonstrate a greater "commonality of interest" when pooling together to offer employees group health plans. The

new regulation allows for employers to band together and offer coverage if they are in the same state or metropolitan area or the same trade, industry, line of business or profession. Under the rule, small businesses can purchase fully insured group health plans or self-insure their health plans, which provides an additional mechanism for groups or associations to meet the definition of "employer" and sponsor a single Employee Retirement Income Security Act of 1974 (ERISA) covered group health plan. Under the rule, associations may establish a fully-insured AHP Sept. 1; existing associations that sponsored an AHP on or before the date the rule was published may establish a self-funded AHP on Jan.1, 2019, and all other associations may establish a self-funded AHP on September 1st. ARCA's Insurance Committee will begin investigating this opportunity to provide needed coverage to our members.

President Trump Calls for Lowering the Corporate Tax Rate

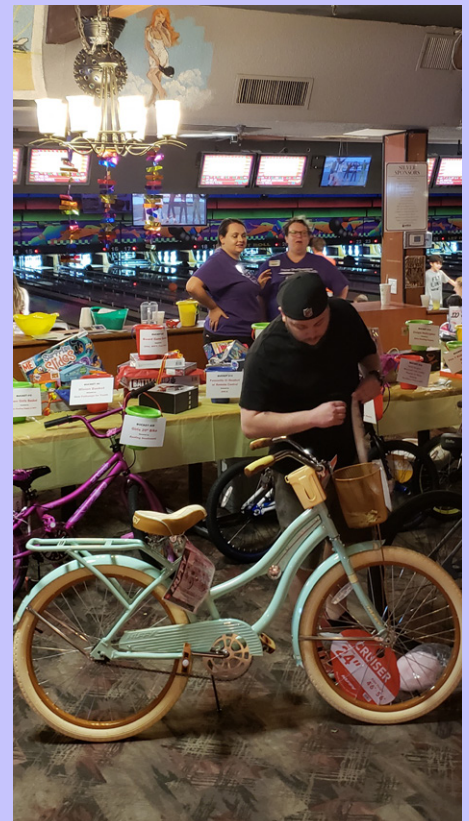
The president announced during a media interview he wants to lower the corporate tax rate to 20 percent as part of a second round of tax cuts beyond those enacted as part of the Tax Cuts and Jobs Act (TCJA) in December 2017, which lowered the corporate tax rate from 35 to 21 percent. The president's proposal comes as the House Committee on Ways and Means is currently working on new legislation, known as "Phase Two," that could make permanent the lower tax rates for individuals and the new 20 percent deduction for pass-through businesses included in the TCJA. The provisions of the new tax law are set to expire at the end of 2025, and if Congress does not pass legislation to extend them or make them permanent, they will lapse and result in significant tax increases Jan. 1, 2026.

New Work Requirements In Food Assistance Program

The House narrowly passed the Agriculture and Nutrition Act of 2018 (H.R. 2), a multiyear farm bill that includes new work requirements for persons receiving food assistance benefits under the Supplemental Nutrition Assistance Program (SNAP). Reforms in the legislation include a new requirement that most adults between the ages of 18-59 engage in employment training for a minimum of 20 hours per week (increasing to 25 hours in 2026) to remain eligible for benefits. The House-passed bill also provides funding for states to modernize employment and training services. The reforms proposed by House Republicans and the Trump administration are designed to expand training to get more individuals using public assistance programs to ultimately join the workforce. 🏠

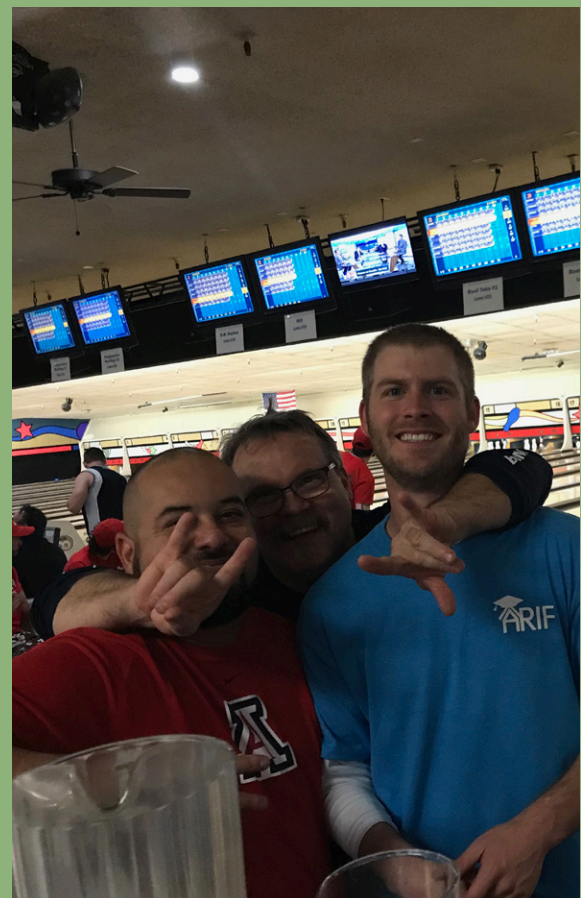

Where necessary, the membrane may be unrolled and cut into 10- to 15-foot lengths. Align membrane on lower edges of roof. Remove release film from membrane and press into place. Roll lower edges firmly with a hand roller. "Broom in" installed membrane using an industrial flat broom or squeegee. Bear down on installed membrane with the broom or squeegee to ensure total, even adherence to substrate.

Care should be taken not to damage the surface when brooming.

VALLEY APPLICATION

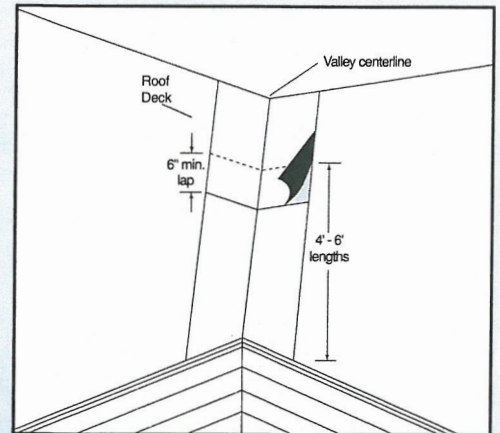
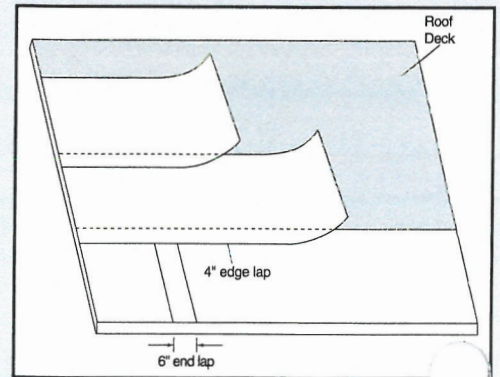
Where necessary the membrane may be unrolled and cut into 4- to 6-foot lengths. Peel the release film and center sheet over valley or ridge. Drape and press sheet into place, working from the center of the valley or ridge outward in each direction. For valleys, apply membrane starting at the lowest point and work upward. Overlap all sheets a minimum of 6 inches. Use TW Metal and Tile Underlayment on "closed valley" applications only. Do not leave membrane permanently exposed. Cover with roofing materials.

Provide ventilation when using TW Metal and Tile Underlayment over the entire roof deck. For information on proper application, contact your architect, building contractor, building materials supplier or TAMKO.

NRCA WASHINGTON, D.C. LEGISLATIVE AGENDA

TAX ISSUES

NRCA WORKED TO ensure the Tax Cuts and Jobs Act of 2017 (H.R. 1) provided lower tax rates to all types of employers to provide entrepreneurs with more capital to invest in their businesses and create high-paying jobs. NRCA now is working to ensure fair implementation of the new tax law, particularly regarding the provisions related to how the new tax rates apply to businesses organized as pass-through entities. Additionally, NRCA succeeded in getting nonresidential roofs included as qualifying property under Section 179 of the tax code in H.R. 1. This new law allows small and mid-sized businesses to fully expense the cost of roof replacements in the year of purchase rather than having to depreciate reroofing projects under the outdated 39-year depreciation schedule. NRCA continues working with Congress and federal agencies to ensure federal tax policy is beneficial to the roofing industry.

REGULATORY REFORM

Roofing contractors have been bombarded in recent years with thousands of pages of regulations from federal agencies, including the Occupational Safety and Health Administration. To provide

long-term regulatory relief for employers, NRCA supports legislation that reforms and updates the federal regulatory process, which has not been updated in 70 years. Such reform is critical to reducing the regulatory burden that has been placed on America's small businesses and unleashing the economic potential of job creators.

WORKFORCE DEVELOPMENT

NRCA supports legislation to improve career and technical education (CTE) programs that operate under the Perkins Career and Technical Education Act of 2006. NRCA's recommended reforms are designed to make CTE programs more responsive to employers' workforce development needs. This includes more effective engagement between employers and educators in program development; expanded opportunities for work-based learning and development of industry-recognized credentials; and increased funding for CTE programs. NRCA believes enacting legislation to reform CTE programs is vital to future workforce development within the roofing industry.

IMMIGRATION REFORM

NRCA supports immigration reform

that increases border security; improves workplace enforcement without burdening employers; provides an avenue for workers to enter the U.S. legally when our economy needs them; and addresses the problem of the existing illegal workforce in a balanced manner. Immigration reform must be governed by market forces, protect U.S. workers, end illegal immigration and enable our nation's job creators to obtain the workers needed to meet demand and grow their businesses.

HEALTH CARE REFORM

NRCA supports efforts to address the rising cost of health care benefits through greater competition, expanded consumer choice, increased transparency in private markets and other market-oriented reforms. A major focus for NRCA is to support legislation to repeal the onerous health insurance tax authorized by the Affordable Care Act (ACA), which drives up health insurance premiums for businesses and individuals that purchase fully insured health benefits. NRCA succeeded in getting Congress to suspend the ACA health insurance tax in 2017 and 2019 and continues working toward full repeal of this burdensome tax. 🏠

NRCA Pro-Certification Update

by Rhonda LaNue (Lyons Roofing)

MANY OF YOU already have heard that NRCA has been working on the development of a Nationally Accredited Training Program known as ProCertification. The program has been under development for the past 2+ years. The program's goal is our greatest wish, developing a competent and sustainable workforce.

The initial phase of ProCertification program will be released in the coming months. There will be a total of 18 certification programs available when complete. The first programs to be released are the TPO/PVC, Shingle and Foremen Certifications. These programs provide comprehensive, and skill based hands on training and assessments in both English and Spanish, as well as supplemental

online training and data.

In order to accomplish this nationally NRCA has begun to establish the necessary network of Qualified Trainers, Assessors (2 different roles) as well as Recognized Training Centers (RTC's) and Authorized Testing Centers (ATC's). These training and testing centers will be fully standardized to provide the same opportunity to all. These resources (ATC's and RTC's) will have agreements directly with NRCA to assure the integrity of the program is maintained.


NRCA currently has 67 ATC's on the roster gearing up for standardized testing, and approximately 90 certified Trainers.

trainers, assessors, standardized training and assessment centers to properly serve all of Arizona—

- Qualified Trainers and Assessors can be experienced roof installers, manufacturers' or distributors representatives.
- Standardized RTC's can be local suppliers or manufacturers, contractors or community colleges and vocational schools.

IRS Releases Guidance Regarding Small-Business Accounting Methods, Issues/Regulations For 100-Percent Depreciation Deduction

ON AUG. 3, the IRS released guidance regarding small-business accounting method changes under the Tax Cuts and Jobs Act (TCJA) of 2017, which was enacted into law in December 2017. This guidance spells out the process by which eligible small-business taxpayers can obtain automatic consent to change accounting methods now permitted under the TCJA, which expanded the number of small-business taxpayers eligible to use the cash method of accounting beginning after Dec. 31, 2017. Also on Aug. 3, the Treasury Department and IRS jointly issued proposed regulations regarding the new 100-percent depreciation deduction that allows businesses to write off most depreciable assets in the year in which they are placed in service. This new 100-percent depreciation deduction generally applies to depreciable assets with a recovery period of 20 years or less and certain other property, such as machinery, equipment, computers, appliances and furniture.
